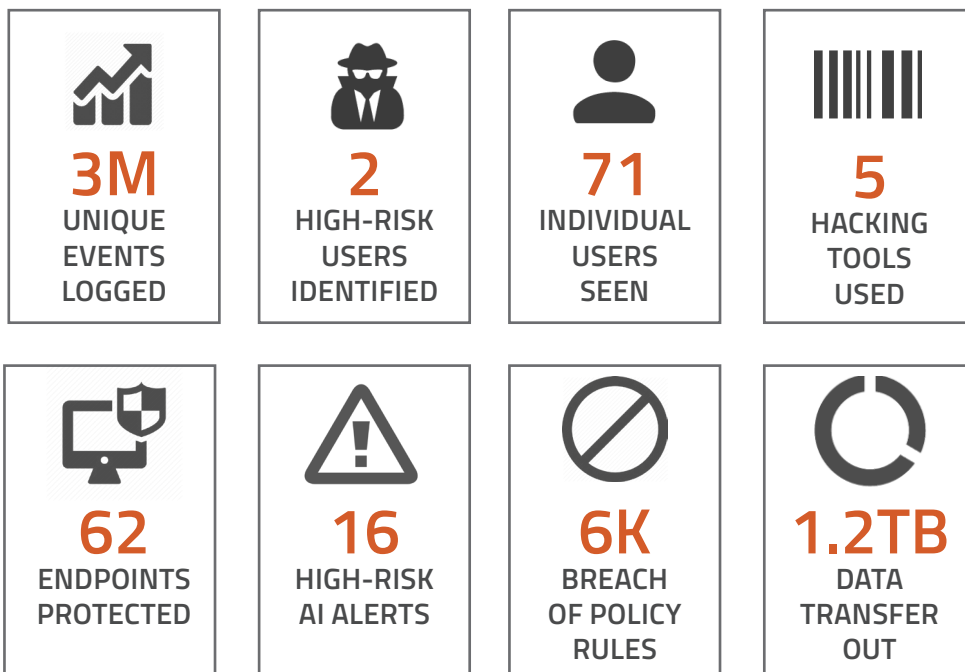
### Illicit movies

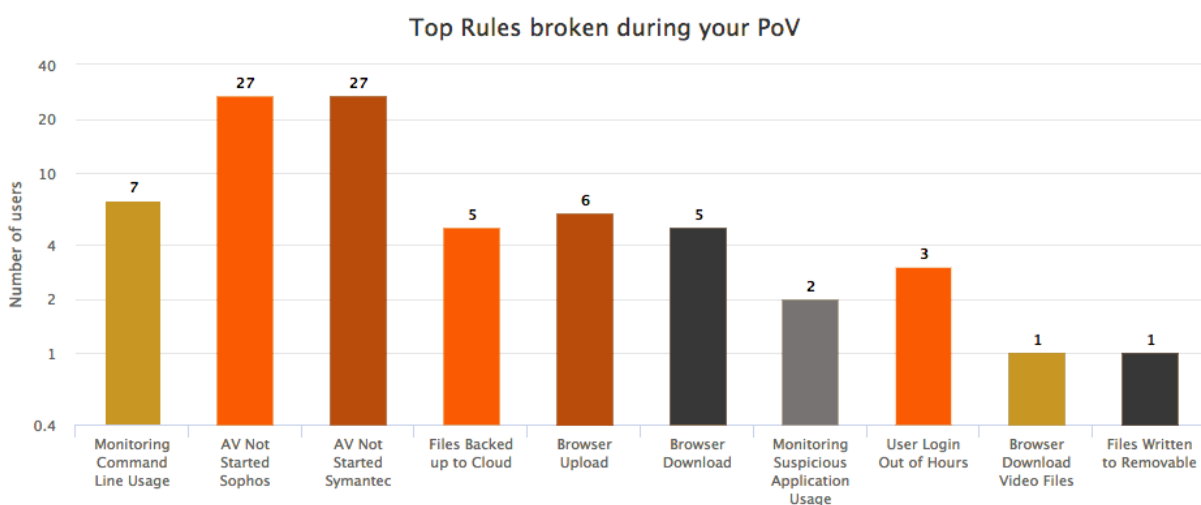
